The Oslo Consular District comprises all of Norway, the island of Jan Mayen, the archipelago of Svalbard, and one law firm from Stockholm, Sweden.

Registered mail may be sent through the Norwegian postal service and return receipts obtained. International reply coupons should be used when it is desired to prepay a reply.

Credit reports are usually obtainable through commercial banking institutions in the United States which have correspondents in Norway or through a commercial reporting agency such as Dun & Bradstreet, Inc.

There are two types of lawyers in Norway. An Advokat (adv.) may plead cases in the Lower Court and the Superior Court. An Advokat (H) may plead cases in the Lower, Superior and Supreme Courts. All attorneys on the list are members of the Norwegian Bar Association (Den Norske Advokatforening) and are not permitted to accept cases on a contingency basis. All attorneys on the list are willing to take on cases at any location in Norway.

In Norway Notary Publics are not attached to private law offices or commercial establishments of any kind. Notarial functions are performed by certain government officials such as Sheriffs (Lensmann), City or District Judges (Tingrett or Sorenskriver).
